This competition is the general public's opportunity to participate in KCBS style BBQ at Currituck Bulls & BBQ, and is intended to create excitement, enthusiasm, and support for a locals children's charity. This is also an opportunity for the cook teams to have their barbecue judged by the attending public.

- 5. **People's Choice** option must be indicated on the KCBS cook team application.
- 6. **People's Choice** is an optional category in addition to the KCBS sanctioned portion of the Currituck Bulls & BBQ event. Entrants must also be competing in the KCBS sanctioned categories (chicken, pork ribs, pork & beef brisket) to compete in **People's Choice Competition**.
- 7. **People Choice Awards** will be presented after the KCBS awards ceremonies (which begin at 4:00pm, during intermission of rodeo). There will be first, second and third Place winners for "Best BBQ" and "Best Side".
 - a. 1st Place Trophy
 - b. 2nd Place Metal
 - c. 3rd Place Metal
- 8. **People's Choice Ticket** Patrons will purchase tickets to participate in People's Choice tasting. Each ticket will include a People's Choice Ballot to vote for their favorite team. Tickets will be \$10 to sample portions from each participating competition BBQ cook team at the People's Choice Tent. Ticket sales, 12 –2:30 (or until BBQ runs out).
- 9. **People's Choice Ballot** Completed ballots will be turned in at the People's Choice Tent by 3:30pm on Saturday.
- 10. **Contest Time** Patrons will need to arrive early. Samples from participating teams are limited and are available from 1:45pm to 3:00pm or while supplies last.
- 11. Participating Cook Team Information:
 - a. Teams participating will be provided meat (3 Butts) and 2 full-size aluminum pans (one for pork entry & one for side entry) at your arrival on Friday, 6th. Teams are required to provide their own choice of side.
 - b. **Bulls & BBQ** staff will visit team site to pick up prepared pans from participating teams at 1:30 pm on Saturday, after your last KCBS turn-in.

- c. No food can be sold to public unless team has applied and accepted as a People's Choice food vendor. Expect Health Inspection Friday afternoon. Scheduled inspection time will be provided to all participating teams at a later date.
 - i. INSPECTION: All participants must complete an application and submit within 15 Days prior to the event. Each application is reviewed by the *Currituck Health Department* to determine whether an inspection is required. *The \$75.00 permit fee is being waived for the People's Choice Competition for all participants. Please see attached document to assure all health requirements are being met (hand washing station, sanitation, etc.) Preparation of food is prohibited until inspection has been conducted.
 - ii. Any participant failing to be set up and ready for inspection will be unable to participate in the **People's Choice Competition**.
- d. Competing teams, including all team members cannot judge in contest. Any violation of this rule will forget this team's future participation in the **Currituck Bulls & BBQ** event.
- e. If cook team family members and friends wish to participate, we ask that they only receive one ballot per family member/friend and vote one time for their favorite. If the event organizers determine that this is being abused, this will disqualify a team from future participation in **People's Choice Competition** and up to forfeiting participation in future **Currituck Bulls & BBQ** events. (Please help us make this fair and fun for everyone.)
- f. The winning teams will be picked by having the most number of votes.
- 12. Please list three <u>SIDE CHOICES</u>, starting with your first choice. *We will only have TWO of any like side item to add variety to the contest. (Ex: Mac & cheese, coleslaw, green beans, collards, etc.) We are trying to avoid all competitors serving the same side item!
