Alcohol Vendor Rules & Regulations

I acknowledge that by signing this Alcohol Vendor Application/Agreement, I will adhere to the following rules and regulations *(please initial after each)*:

1. I/We understand that all Corolla Cork & Craft alcohol vendors must be North Carolina alcohol vendors. I/We produce my/our alcohol in North Carolina. _____
2. The Corolla Cork & Craft event is every Wednesday starting June 12th through September 11th, from 3:00 pm to 7:00 pm. (***NO BREAK DOWN BEGINS BEFORE 7:00 PM.***) _____
3. Set-up time may begin at 1:00PM on scheduled date(s). Alcohol Vendors will be allowed to drive their vehicle up to their booth during scheduled set-up time and scheduled tear-down time ONLY. At all other times, vehicles must remain in the designated parking area. **NO VEHICLES WILL BE ALLOWED ON SHOW SITE DURING SHOW HOURS.** This is to ensure the safety of customers and spectators as there will be excessive foot traffic in the park. Site assignments will be given upon arrival at your set-up time. _____
4. Booth size is 10' x 10'. One (1) tent, two (2) tables, and two (2) chairs will be provided by Currituck County Travel & Tourism. Tents, tables, and chairs will need to be set up by each vendor. Tents will need to be staked in the ground. All provided items must be packed up and returned by the alcohol vendor at the conclusion of the event. Failure to do so will result in us not providing those items for the rest of the Corolla Cork & Craft 2024 season. _____
5. Alcohol vendors must provide their own glasses and wash stations. The county will provide ice. _____
6. Trash receptacles are located throughout the park for our vendor's and our visitors' convenience. However, any bulk trash is to be placed in the dumpster located at the public boat ramp area. _____
7. All booths must be manned during show time. _____
8. Photography/Video Consent: Please note that by participation in the event, vendor grants permission of photo and video to be used for the marketing purposes of Currituck County Travel & Tourism. _____
9. Each alcohol vendor must provide Currituck County Travel & Tourism the appropriate ABC Permit(s). _____
10. **Insurance:** Each alcohol vendor is required to provide Currituck County a Certificate of Liability Insurance (COI) in the amount of \$1,000,000.00 naming the **County of Currituck** as the "Additional Insured." The "Certificate Holder" should read, **County of Currituck, 153 Courthouse Road, Currituck, NC 27929. **Your company will not be able to work on the property or participate in Corolla Cork & Craft without this COI on file. Please submit your COI no later than June 1, 2024.*** _____

***PLEASE NOTE: Failure to comply with these rules and regulations may result in the termination of Corolla Cork & Craft participation.**
